## 1. ELIGIBILITY OF PARTICIPANTS

- 1.1. This tournament is opened to all Singapore Citizens, Permanent Residents, and individuals residing and/or studying in Singapore with valid passes, for Age Categories.
- 1.2. **Overseas participation is allowed** in all categories.
- 1.3. Age qualification shall be based on the following: **(CALENDAR YEAR)**

Age Group	Birth Year	Age in 2019
Under – 9	Born in 2011 or later	8 years old or younger
Under – 10	Born in 2010 or later	9 years old or younger
Under – 11	Born in 2009 or later	10 years old or younger
Under – 12	Born in 2008 or later	11 years old or younger
Under – 13	Born in 2007 or later	12 years old or younger
Under – 15	Born in 2006/2005 or later	14 years old or younger
Under – 17	Born in 2004/2003 or later	16 years old or younger

- 1.4. A player can participate in his/her age group category or a higher age group category but NOT in a lower age group category. (E.g. A player 12 years of age in 2019 is eligible to participate in the U-13 / U-15 / U-17 Singles and Doubles events).
- 1.5. Organizers may request evidence of eligibility during the tournament. Any player found ineligible will **NOT** be allowed to play and the player will have to concede walkover for that match. There will be **NO** refund of entry fee.

## 2. ENTRY & REGISTRATION

- 2.1. Each player is ONLY allowed to enter a **maximum of 4 events**. More specifically, each player can enter up to **TWO Singles AND TWO Doubles events** (2 doubles; or 2 mixed doubles; or 1 doubles & 1 mixed doubles), either within their age group or higher.
- 2.2. The registration fees for each event are as follows:
  - 2.2.1. Singles – S\$50.00 per entry
  - 2.2.2. Doubles– S\$100.00 per pair (incl. Mixed Doubles)
- 2.3. Payment for the registration fee is accepted in **cash, cheque, online** and is non-refundable.
- 2.4. Closing date for registration is on **3 November 2019**. Registration without payment is deemed as incomplete. Late and incomplete entries will NOT be entertained. Bounced cheques will result in entries being voided.
- 2.5. All cheques to be made payable to “**World-Champ Marketing**” and crossed “**A/C Payee only**”. All cheques and cash payments must also be accompanied by a hard copy of the duly completed registration form and submitted by **3 November 2019** to:

- 2.6. A minimum of 16 entries per event will be accepted on a first-come-first-served basis. The Organizing Committee reserves the right to conduct qualifying round if it decides to accept more than 64 entries.
- 2.7. List of participants will be released on **10 November 2019**.
- 2.8. The Organizer will conduct draws on **18 November 2019**.
- 2.9. The above information stated in 2.7 and 2.8 will be released on the tournament website and announced on our official Facebook Page: <https://www.facebook.com/victorsport.sg>.
- 2.10. Seeding will be based on World-Champ National Age Group Ranking based on Pilot Pen Championship 2019, Global Eduhub Championship 2019 and Temasek Club Championship 2018 badminton championship results (not in any order).
- 2.11. In the event of insufficient entries for any event (i.e. less than 16 entries), the event/s may be merged with the same event of another age category or be cancelled.
- 2.12. If there are less than 16 entries in any event, the prize money/ prizes for that event may be reduced.
- 2.13. The prize money will be determined by World-Champ Marketing, the organizer for this tournament.

### 3. TOURNAMENT FORMAT

- 3.1. The tournament will be a **single knockout** format for all events.

### 4. TOURNAMENT RULES

- 4.1. The tournament will be conducted in accordance with the current Badminton World Federation (BWF) rules.
- 4.2. All matches will be played in accordance with the schedule of play. Postponement of any matches will be at the Organizing Committee's discretion.
- 4.3. All players are required to bring along their **photo identification documents** for verification on days of their matches upon registration.
- 4.4. Once entries have been accepted, no replacement/substitution of players will be entertained. However, the Organizing Committee, at its discretion, reserves the right to accept such changes if necessary and with valid reasons, so long as no match has been played by the player/s.
- 4.5. All players must report to the Official Registration Table at least 30 minutes before the scheduled time of their matches.
- 4.6. Players will be given a grace period of a **maximum 5 minutes** for all matches, failing which the player will concede a walkover for that particular match.
- 4.7. In the event that both players fail to turn up, the match will be scratched.
- 4.8. Players who concede a walkover in one event, will still be allowed participation in other events, unless otherwise decided by the tournament referee.
- 4.9. Players shall wear non-marking shoes during the competition.
- 4.10. The competition format will be based on the best of **3 games of 21 points** for all categories.
- 4.11. Players are given a **minimum of 30 minutes** rest period before commencement of the next match at any round (including semis & finals).
- 4.12. The decision of the umpires and officials shall be deemed as final.
- 4.13. Players are required to stay on the court **AFTER** their match had ended, to act as line judges for the following match. Players who fail to do so will lead to a disqualification and/or ban from future tournaments. Players may also be called randomly to act as line judges for the 1<sup>st</sup> round of matched for the session.
- 4.14. There will be line judges provided from the finals onwards.
- 4.15. From quarter-finals onwards, all doubles pairs are required to wear **attire of at least the same color**, if not the same design and color.
- 4.16. The Organizing Committee has the right to amend the rules & regulations prior to the commencement of the event.
- 4.17. Victor Champion No. 1 shuttlecocks shall be exclusively used for the Under-15 and above events.
- 4.18. Victor Gold shuttlecocks shall be exclusively used for the Under-13 and below events.

## 5. PRIZE & INCENTIVES

5.1. Total incentives in the form of **cash/vouchers/rackets** worth \$23,000 to be awarded to prize winners.

5.2. The results of this tournament will be used to invite players to participate in international age group tournaments. Selection criteria are at the sole discretion of the organizing committee.

5.3. Prize winners are required to attend the prize presentation ceremony in proper sporting attire. **NO** singlet or slippers are allowed.

5.4. Prize winners are to proceed to the tournament table after the prize presentation ceremony to collect their cash prize money.

5.5. Prize money will be reduced accordingly depending on the number of entries.

## 6. REFUND POLICY

6.1. Unless the Organizing Committee cancels the event, there will be no refund of the entry fees.

## 7. WAIVER AND RELEASE FROM LIABILITY

- 7.1. All warranties, conditions and other terms implied by statute or common law are hereby, to the fullest extent permitted by law, excluded. I warrant, represent and agree that:
- 7.1.1. I am in good health and have no physical conditions that affect my ability to participate in any activity at the Venue and have not been advised otherwise by a medical practitioner.
- 7.1.2. I hereby personally assume any and all risk from participating in any activity / programme.
- 7.1.3. I agree to indemnify, defend and hold harmless World-Champ Marketing and its employees, agents, contractors, instructors and volunteers from and against any claims, causes of action, damage, judgments, liabilities, fines imposed, fees (including legal fees), costs and expenses incurred by them as a result of my actions or failure to act during any activity.
- 7.1.4. In the event of an accident or illness requiring urgent medical treatment, I give permission to receive any emergency dental, medical or surgical treatment, including anaesthetic or blood transfusion, as considered necessary by the medical authorities present (if any).
- 7.1.5. I assume all risks from my participation including without limitation the risk of any negligence or recklessness by other participants. I understand that there may be risks involved which are not known to me or to World-Champ Marketing at this time, or the time of the activities in which I may participate, and agree to assume such unforeseeable risks
- 7.1.6. I understand that this section (Waiver and Release from Liability) is legally binding and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions of this Agreement found to be unenforceable shall not affect the validity or enforceability of any other provisions, which may be modified by a court having jurisdiction.

## 8. CONSENT TO PHOTOGRAPHY / VIDEO

- 8.1. I give consent to World-Champ Marketing to use my images from any photo / film shoots and waive all rights to the images. By providing your personal data in this form, you hereby consent to the collection, use and/or disclosure of your personal data (or the personal data of your representative) by World-Champ Marketing for the aforementioned purposes.

- 10.1. While reasonable precautions will be taken, the organizer will not be responsible or in any way liable for any death, disability, personal injury, loss of property or any other loss howsoever arising from any cause whatsoever at any time during the course of this tournament.
- 10.2. The Organizer reserves the right to amend the Terms & Conditions set out in this prospectus at its sole discretion without prior notice.
